The purpose of the Delúvia Diva Rep Program is to give individuals who love our products the opportunity to sell them. Within this Agreement, the Delúvia Diva Independent Beauty Representative will be referred to as the "Rep." Within this Agreement, Delúvia and all subsidiary products (including but not limited to Demúre mineral make-up, Delúvia Dead Sea skin care and Luvín Life Organics body care) will be referred to as the "Company."

INDEPENDENT BEAUTY REP WANTS AND AGREES:

- 1. To promote and sell Delúvia® ("Company") and its product lines direct to consumers.
2. To maintain a high level of honesty and responsibility in dealings with the Company and its customers. Rep also agrees not to make promises or claims which would impair the reputation or goodwill of the Company. Rep agrees to hold the Company harmless from damages resulting from misrepresentations by Rep.
3. If Rep wants to sell products on a website, the pricing structure must not undercut the prices on www.DeluviaUSA.com. Prices must be equal to or greater than these prices. Rep may not sell Delúvia products on internet auction sites (such as Amazon, EBAY, Overstock, etc).
4. Rep understands that the display and sale of Company products in retail establishments, flea markets, craft shows, or on the internet is in violation of this Agreement unless prior written approval is obtained.
5. As an independent contractor, Rep assumes sole responsibility and liability for all self-employment income taxes and any other reports required to abide by local and federal laws governing Rep's sales.
6. Rep understands that as an Independent Contractor they are not an agent, partner, or employee of the Company.
7. Rep agrees to comply with any future changes to the General Terms and Conditions of this Delúvia Diva Independent Beauty Representative Agreement that may be made by the Company.
8. Rep agrees that any unresolved dispute relating to this Agreement will be resolve by a mediator in Clearwater, Florida.

9. If a Rep purchases products for themselves using their Diva code, a commission will not be paid. If a Rep is found to be using this Program in order to buy products for themselves, their Diva Account will be cancelled.

DELUVIA ("Company") AGREES:

- 1. Commission payments will be paid monthly to the Rep via a check once a month.
2. No geographical territories or limits concerning sales are placed on Rep.
3. Rep has the option to cancel this Agreement at any time with written notice.
4. If a Rep's customer returns product for refund any commission paid to the Rep will be deducted from future commissions. If not commission is due, Rep agrees that their credit card will be charged for the commission refund.
5. The Company is not responsible or liable for the statements, acts or omissions on the part of the Rep.
6. This Agreement along with any accompanying signed addendums constitutes the entire Agreement between both parties.
